

# Washington State Declaration of Write-in Candidacy for President and Vice President

## when to file

Your declaration must be received between **January 1, 2024** and **November 5, 2024**.

## where to file

### 1. office

Select which office you are filing for as a write-in candidate.

A separate form is required for each candidate (President and Vice President). Submit both forms together.

You are responsible for ensuring that you meet all qualifications of the office.

### 2. personal information

Enter your residence and personal information.

### 3. campaign information

If you do not provide campaign information, your personal information will be used as the primary contact information.

Government office addresses may not be used for campaigns.

A telephone number, website or email address is not required, but recommended.

Your name will not appear on the general election ballot nor in any official voters' pamphlet.

### 4. oath

Read, sign, and date the oath.

There is no filing fee for the offices of President and Vice President of the United States. A write-in candidate is not required to submit a certificate of nomination.

Once filed, a declaration of write-in candidacy may not be altered.

## results

Write-in votes are not tallied for individual write-in candidates unless enough total write-in votes are cast to potentially change the outcome of the race.

As a declared write-in candidate, any recognizable variation of your name will be counted.

Should you win, you must submit the names and addresses of 12 qualified electors for the electoral college.
